## **Enabling Community led Innovation**





- We identified the need for greater levels of 'Community led Innovation'
- Through LEADER cooperation, we developed <u>Innovating Communities</u> designed to stimulate local innovation and improve problem-solving
- Communities invited to identify local challenges / opportunities, (6 LAGs)
- Projects with sufficient support selected to progress to facilitated training
- Used 'Design Thinking' as an iterative process to problem-solve / engage
- A strong focus on 'learning by doing' a facilitated process











# A Focus on Supporting Social Innovation





- Key Outcomes:
- ▶ **1,470** people trained in problem-solving tools
- > 227 opportunities & **51 challenges** identified
- Many new cohorts engaged (i.e. Youth, Migrants)
- High satisfaction rates of participants >90%
- Over 70% of participants agree that taking part in the course has helped them with new ideas for their communities
- 38 local Co-Trainers to embed the legacy of IC
- A LEADER <u>Showcase Event</u> to share the learning





# Participant comments on the IC approach

#### **Key Learning**





- ► Todays rural challenges are complex & require new ways for communities to engage and problemsolve (i.e Climate Change, Migration etc), but as we see from the LEADER funded <u>Innovating Communities</u> ex, rural communities will step up to the challenge if supported.
- ► The Place-based approach is not just about funding, it means harnessing the skills of a rural area by digging deep to engage a wider cohort of creative and passionate people in a developmental process which can make a difference and drive innovation and change. *This is the core of the LEADER method.*

#### **Policy Recommendations**

- ► LEADER Programme funding is insufficient for the scale of the rural challenge we need an integrated approach with greater strategic use of all the Funds for CLLD multi-fund approach. (ESF, ERDF etc
- ► LEADER Cooperation is a key development tool for rural areas financial supports should be focused on the Social Innovation and collaboration potential of Local Action Groups
- LEADER has a strong synergy with the **Smart Village policy agenda** and is an ideal vehicle for Rural areas **to** develop Social Innovation capacity requires a strong community developmental approach, which in turn needs greater investment in LEADER and a greater appetite for local experimentation.
- ► Place matters and our communities are changing LEADER Programme is ideally placed to drive rural Innovation, reinforce and empower place-based development and strengthen social cohesion and play its part in achieving the objectives of the LTVFRA.
